<b>TEXTBOOK</b>	<b>Autodesk Inventor Professional 2021 for Designers - <u>Author:</u> Sham Tickoo - <u>Publisher:</u> CAD/CIM Technologies (Provided as an E-book as part of the class on Blackboard)</b>
<b>DESCRIPTION</b>	This course further develops computer-aided modeling. Development of three-dimensional models and orthographic drawings from those models and utilization of three-dimensional models in design work.
<b>SCOPE</b>	The scope of <u>Solid Modeling and Design</u> will be for sixteen weeks, which will include two (2) hours of lecture per week and four (4) hours of laboratory experience per week, for a total of ninety-six (96) contact hours per semester.
<b>COURSE OUTCOMES</b>	Create three-dimensional solid model objects; and generate pictorial and orthographic drawings.
