**Course Description:** In-depth study and applications of polynomial, rational, radical, exponential and logarithmic functions, and systems of equations using matrices. Additional topics such as sequences, series, probability, and conics may be included.

**Prerequisite:** Minimum score of 350 on the TSIA, TSI-exempt status, or a successful completion with a grade of 'C' or better in MATH 0320.

3. Apply graphing techniques.
4. Evaluate all roots of higher degree polynomial and rational functions.
5. Recognize, solve and apply systems of linear equations using matrices.

**Student Learning Outcomes Assessment:** A pre- and post-test questions will be used to determine the extent of improvement that the students have gained during the semester

**Course Evaluation:** There will be departmental final exam questions given by all instructors.

**Attendance/Student Engagement Policy:** Attendance and effort are the most important activities for success in this course. The instructor maintains records of the student's engagement throughout the semester. The student will be allowed to miss twenty percent (20%) of class assignments for the semester, **for any reason**. Should this number be exceeded, the instructor has the right to drop the student with a grade of F or an X, depending on the instructor's discretion.

### Online Homework

Homework is assigned online through [MyLab Math](#). The homework enables students to receive feedback immediately as progress is made through each assignment.

- Physical homework is not required to turn in. But please be sure to take notes!
- You will have unlimited attempts before the due date without penalty. Be sure to finish well before the due date.
- Homework assignments cannot be made up after the due date.

### Quiz Assessments

Quizzes are also assigned through MyLab Math and are based on the homework assignments.

- These problems will test the student's ability to simplify, solve, and graph.
- Quizzes are timed 60 minutes (1 hour) and cannot be made up under any circumstances.

### Exams

Exams are posted online in Blackboard (Not MyLab Math!). You will be using Gradescope to turn in your Exams by scanning your work.

- Exams are formatted in the following way:
  - Conceptual Section: True/False and Fill in the Blank problems.
  - Application Section: Simplifying expressions, solving equations, graphing functions – show ALL work!
  - Bonus Section: One problem that is worth up to 10% extra credit
- Exams will be timed from **8:00 AM to 10:00 PM**; this is a **non-negotiable** timeframe.

### Final Exam

The Final Exam is *comprehensive* and will be assigned on **Friday, July 8<sup>th</sup>**

- Failure to attempt the Final Exam will result in a failing grade for the course.

- The Final Exam will replace one (1) missed Exam or your lowest scored Exam. Otherwise the Final will note replace any grade.
